

Home Deco Campaign: Terms and Conditions

Welcome to Courts Mammouth Home Deco! By enrolling to the campaign, you agree to be bound by the terms and conditions set out below.

Eligibility Criteria

1. Age Requirements

The promotion is open to individuals who are residents of Mauritius and are 18 years of age or older at the time of entry.

2. Exclusions

The following individuals are not eligible to participate in the Home Deco promotion:

- Employees of Courts Mammouth, including its affiliates, subsidiaries, and associated companies.
- Immediate family members of the above-mentioned employees (including parents, spouses, siblings, and children).

3. Verification of Identity

Once the winner has been selected, a second site visit will be conducted at the winner's premises with the full project team to finalize assessments and next steps. The selection process will remain fair, transparent, and compliant with the stated terms.

2. Notification Method

The winner will be notified using the contact details provided during the entry submission. Notifications may be sent via email, phone call, or any other method specified by Courts Mammouth during the entry.

Prize Details

1. Description of Prize

The prize will consist of transforming the room where you have installed your new furniture purchased from Courts Mammouth and the revamp of a second room of your choice whether it is your dining room, living room, office, or bedroom—completely FREE of charge with furniture and decor from Courts Mammouth.
